



Adding a course prerequisite for BACC 408, Accounting Information Systems (3).

b. A rationale for the change

The Accounting Department proposes to add another prerequisite for BACC 408. The proposal is to add Management 100 as a prerequisite. BACC 408 (Accounting Information Systems) requires an understanding of the use of computers in business – a topic covered in Management 100. Although most students have completed Management 100 (or the equivalent) before enrolling in BACC 408, there are some post-baccalaureate students who sign up for the class without a good grasp of the use of computers in business.

a. A description of the change

Changing course prerequisites for BACC 412, Taxation of Estates, Gifts and Trusts (3) AND changing the course FROM a BACC course TO a BUSA course AND changing when the course is offered.

b. A rationale for the change

Regarding change in course prerequisite – The current prerequisite of the course is BACC 307, Federal Tax Accounting (3). BACC/BUSA 412 does not require an understanding of federal income taxes. Instead, it requires an understanding of legal issues and legal research which is covered in BUSA 335.

Regarding the change FROM BACC to BUSA – the course does not cover accounting topics. Instead, it covers legal-related topics. Because the College of Business does not have a separate designation for legal-related courses, the accounting department would prefer this courses be “housed” in the General Business Administration (BUSA) area.

Regarding when the course is offered – the course is only offered in the summer.
