Please note that the financial aid award process for the summer term is different from the fall-spring aid award process.

A. Important information regarding Summer Aid:

1. You must register for summer classes before submitting this application.
2. You will be “offered” the maximum amount of aid you are eligible for; you must go on your My Mocsnet account and accept what aid you wish to receive for all of the summer 2010 term.
3. Any changes in your class schedule may result in the loss of your student aid eligibility or delay in receipt of student loan funds. Check with the Financial Aid Office before you drop ANY summer credits for any previously registered period, or if your schedule doesn’t match the hours/terms listed on this application. You must submit a new Summer Aid Application if you change your enrollment in any way.
4. Funds for summer aid are often limited, but may include Pell Grants, Stafford Loans, Parent and Graduate PLUS Loans, and alternative (private) credit-based loans. We will determine any remaining grant or scholarship eligibility before awarding or recommending these loans.
5. All summer Stafford, Parent PLUS and Graduate PLUS loans are released in two separate, equally spaced disbursements.
6. Loan disbursement dates and payment dates are different. Check with Financial Aid for your loan payment date(s).
7. You must be making Financial Aid Satisfactory Academic Progress for all federal aid, including Stafford, Parent PLUS and Graduate PLUS loans.
8. A minimum of 6 credit hours is required for Stafford and PLUS loan eligibility.
9. Parent PLUS loans for the summer term require a Summer PLUS Information Form be completed.
