## *Description of National Study of Leadership in Middle Level Schools*

*Phase I: A Study of 1400 Middle Level Schools (2000-2002)*  
*Phase II: A Study of 98 Highly Successful Schools (2002-2004)*

### *History*

Since 1966, the National Association of Secondary School Principals (NASSP) has provided support and funding for several comprehensive studies of the Principalship. The 1966 study of Junior High Schools provided an initial perspective of junior high school principals. In 1980 the Association sponsored the first national study of “middle level” schools, which set the standard for detail while providing comprehensive baseline data to analyze changes and trends in middle level leadership and programs. A follow-up study was conducted in 1990, concluding that middle level education had developed a unique and solid foothold in the educational community.

### *Phase I*

The 2000 study documented the major changes and trends over the life of middle level education. All middle level schools, (N=14,000) were invited to participate in the on-line survey for Phase I. Approximately 10% responded, generating a substantive amount of data on leadership, teachers, curriculum, school reform, and middle level concepts. The study provided essential data used repeatedly by principals, school district leaders and district policy makers as they contrast their work with that of schools across the nation. Phase I of the report was released by NASSP in February, 2002 (Valentine, J., Clark, D., Hackmann, D., Petzko, V. (2002), National Study of Leadership in Middle Level Schools, Volume I: A National Study of Middle Level Leaders and School Programs.

### *Phase II*

Phase II of the research focused on the identification of highly successful schools and their principals. Representatives from each state were asked to nominate three to five (3-5) schools that they considered to be “potentially exemplary”. These schools were then asked to participate in a second on-line survey, where their programs and practices were analyzed across the standards of middle level reform. Ninety-eight (98) highly successful schools were identified; six representative schools were visited in the spring of 2002. Phase 2 of the study presents a comparison of highly successful schools to the national sample, identifies common characteristics of highly successful schools and builds a model for exemplary schools. Phase II of the study was released by NASSP in December, 2004 (Valentine, J., Clark, D., Hackmann, D., Petzko, V. (2004), National Study of Leadership in Middle Level Schools, Volume II: Leadership for Highly Successful Middle Level Schools.

### *Significance*

NASSP is the leading organization for middle and high school principals across the nation. Its funding of this research speaks to the project’s significance; its distribution of both Volumes I and II to all middle/high school membership speaks to its effect. Invited presentations have been done at the national convention annually since 2001. The study and its impact will have lasting effects on middle level education: it not only identifies the “state of the art” (Phase I) but also clarifies how highly successful middle level schools differ from the national norm (Phase II). Implications regarding leadership, programs and practices will provide recommendations for the next several years. National presentations, Volumes I and II, and “spin-off articles” have provided insights and suggestions regarding best practices in leadership and programs for middle level schools.
