DESCRIPTION AND LEARNING OBJECTIVES

UTC catalog description: The foundations, institutions, processes and policies of American national government with attention to the Constitution and such topics as elections, political and civil rights and liberties, federalism, public policy, public opinion, political culture, interest groups, and the role of citizens in governance.

Political Science 1010 fulfills one of the general education requirements in the category of Behavioral and Social Sciences. The course has three objectives:

1. Ensure comprehension of the key principles of the American political system.
2. Familiarize students with the structure and workings of the American political system.
3. Analyze the powers of the modern Presidency, the Congress, and the federal judiciary.

Lecture, readings, discussion, and assignments will give students the opportunity to achieve these learning objectives. The course is organized in four parts:

1. Introduction, the Constitution, & Congress
2. The Presidency & the Federal Judiciary
3. Economic and Social Policy, Civil Liberties, & Civil Rights

EXPECTATIONS

Class preparation Students are expected to be well prepared for each class session by completing and thinking critically about readings and assignments.

Class participation The course will be beneficial only if students participate in class discussions and exercises. As the instructor desires all students to benefit from the course, full participation is expected of all students. Students' participation is expected to be of a quality that will contribute to other students' learning. A participation grade will be assessed for the entire semester.

Attendance Accomplishing the learning objectives of the course will require listening to lectures and participating in class discussions and exercises. Much of the course content will only be covered during class lectures and discussions. Students are not required to attend all class sessions. However, absent students are responsible for making arrangements to obtain missed lecture notes, handouts, announcements, etc., from other students. Ten (10) bonus points will be awarded to those students with perfect attendance (or zero unexcused absences). Five (5) bonus points will be awarded to those students with only one (1) unexcused absence.

Academic integrity Careful adherence to standards of academic integrity is expected of all students. Standards of academic integrity will be discussed in class, but students are ultimately responsible for ensuring that they understand and follow these standards. To this end, students are encouraged to consult the student handbook's discussion of the UTC honor system. To protect the academic integrity of this university and this course, the instructor takes plagiarism and other forms of academic dishonesty very seriously and seeks the most severe sanctions available in response to instances of academic dishonesty.

REQUIREMENTS AND GRADING

Three (3) exams will be given during the semester. Each examination can feature multiple choice, true/false, short answer, and/or essay questions. Exams will cover assigned readings, lectures, and class discussions. (100 points each)

There will be a comprehensive final examination. This examination will cover material from the entire semester. (100 points)

For the three class meetings in Section 4 (11/4, 11/11, & 11/18), you will be divided into small groups to discuss public policy issues. There will be no exam for this section. However, you will receive 33 points for each of the three class meetings for attendance and participation. Small groups will be randomly selected. You are expected to be informed and prepared to discuss all of the topics for the specific class meeting.

For each of the four sections that will be covered during this course, students will be given a short written assignment. This assignment will be completed by the student and submitted via UTC Learn (Blackboard) at the specified date and time. The assignment topic will be discussed and determined by the instructor and students present in class. The assignment is as follows:

Please submit a short (single-spaced) reflective essay in response to the assigned topic. The assignments will be worth 50 points each. Please be prepared to think critically about the topic. While a specific page length is not required, most students typically take 1-2 pages to answer the question.
