# Mary and Paul Starnes Scholarship for Educational Excellence

# **About the Scholarship Fund**

The Chattanooga Hamilton County Retired Teachers Association (CHCRTA) is privileged to offer the first annual Mary and Paul Starnes Scholarship for Educational Leadership. The scholarship memorializes the lives of two outstanding leaders who left a lasting legacy on the profession of teaching and service to their community. Mary Starnes' career included 36 years as an educator, primarily at East Ridge High School, and as the Hamilton County Schools Coordinator of Language Arts. Paul Starnes served as State Representative for Chattanooga from 1972-1990. While in office he also served on numerous committees and worked in the education system in different capacities throughout southeast Tennessee. In 2019, this scholarship is a one-time award of \$2,000.00 to a candidate matching the scholarship criteria.

#### **Scholarship Criteria**

- The recipient will be a graduate of an accredited college or university.
- Applicants must be a current or former employee of Hamilton County Department of Education
- Applications are accepted from individuals, holding an active educator licensure in the State of Tennessee. Teachers currently
  employed by school districts outside of Hamilton County or in private schools are not eligible.
- The award will be used for financial support for a graduate level course to further their knowledge and expertise in the field of education.
- Applicants must be accepted by and attend a regionally accredited, non-proprietary, college or university.

# In order to be considered for this scholarship, applicants must submit the application along with the following information.

- A copy of your TN Department of Education License <a href="https://tdoe.tncompass.org">https://tdoe.tncompass.org</a>
- Official transcript from college / university most recently attended.
- A typed two-page essay. (Essay details below)
- One-to-two page resume using a bullet point format. Include educational background, extra-curricular activities, work experience, community involvement, accomplishments, etc. Examples of a 'bullet point resume format' are available on the Internet.
- One letter of recommendation from a school principal, supervisor, college or university professor who is familiar with the applicant's ability, work ethic, character and teaching potential. The letter must be typed on letterhead stationary.

# **Scholarship Essay**

Essay Question: Why should a certified classroom teacher continue to pursue additional training in the field of education?

Teaching is a versatile and dynamic career, and it is important to make connections within the field of education.

Scholarship applicants should draw on their own experiences when responding to this question.

- Essay format: Double spaced, Times New Roman 11 or 12 point font, one-inch top, bottom, and side margins.
- Length: Approximately 500+ words, with a maximum length of two-page typed essay.
- Compliance: No identifying information on the essay, such as school systems, individual schools, names of supervisors, etc.
- Scoring Guide: Refer to the CHCRTA Scholarship Essay Rubric.

#### **Mailing Instructions**

- The scholarship application and supporting documents including the essay must arrive in one packet.
- It is best to use an envelope that will hold the application and accompanying documents without folding it, but not required.
- To be considered for the Mary and Paul Starnes Scholarship for Educational Excellence, mail the application in its entirety to the
  following address. The packet must be <u>received</u> by Thursday, April 5, 2019 at 5:00 pm. Emailed, faxed, late and/or incomplete
  applications will **not** be considered.

- The scholarship recipient and a guest will be invited to attend the CHCRTA meeting in August where he or she will be presented to the CHCRTA members
