Faculty News



In February 2016, Dr. Steve Banks presented a research paper at the Eastern Educational Research Association (EERA) annual conference in Hilton Head, SC. The research study, "Work Environment and Job Burnout in Higher Education Information Technology Employees," was designed to measure relationships among work environment, demographic factors, work-related characteristics, and job burnout in 128 Higher Education IT employees. The Work Environment Scale, the Maslach Burnout Inventory, and a self-report questionnaire were

used to survey these relationships. Several significant predictors of job burnout were noted, and work involvement and work pressure accounted for most of the variance in predicting job burnout.



During the Fall 2015 semester, Dr. Hinsdale Bernard conducted an exploratory pilot study, "The Effect of Using a Three-dimensional Periodic Table (3DPT) of the Elements on Science Achievement among Eighth Grade Students in Southeastern Tennessee." The study was designed to introduce a 3DPT to a group of eighth-grade students and compare their science scores to a comparison group that was taught science in a traditional manner. Science achievement was measured

using the TCAP Science test and results indicated that the treatment group scored significantly higher than the comparison group. No gender and ethnicity differences were evident, but there was a socioeconomic level difference.
