Cost of Attendance Estimates for UTC students 2011-2012 Academic Year

A student's Cost of Attendance (COA) is made up of both direct and indirect costs. Direct costs reflect those charges that appear on a student's bill such as tuition, fees, and on-campus housing. Indirect costs are those charges that are associated with attending UTC, but are not added to a student's bill. These costs reflect such items as off-campus housing, books and supplies, personal expenses and transportation. **YOUR** student's actual cost of attendance figure for the 2011-2012 year is available on their myMOCsnet account, but the chart below should give you an idea of the cost of attendance figure that the Financial Aid Office will be using to figure PLUS Loan eligibility.

You may borrow a PLUS Loan to help with both direct and indirect costs. However, we want you to be aware of the maximum cost of attendance figure for your student, especially if you choose to borrow the maximum PLUS Loan and have these proceeds distributed directly to the student.
