## PCAT Requirements

## Early Decision Application

ETSU's Bill Gatton College of Pharmacy Participates in the Early Decision application through PharmCAS. The deadline is September 3. In addition to completing the PharmCAS application, you must arrange for PharmCAS to receive all of your official transcripts and fees by the deadline. If your application, transcripts, or fee arrive after the deadline, PharmCAS will automatically change your file from early decision status to regular status. If you are offered admission as an Early Decision applicant, you are expected to accept the offer and will not be permitted to apply to other programs in PharmCAS during the current admission cycle. If, however, you are denied admission as an Early Decision applicant, you may apply to other Pharm.D. programs for an additional fee. Refer to the [PharmCAS application fee schedule](#) to determine the cost to apply to each additional program. On October 21 PharmCAS will automatically release all Early Decision applicants who have not been accepted to date, so they may apply to additional programs. Early Decision applicants who are extended an admissions acceptance will receive a \$2,000 scholarship. Additionally, the class reservation deposit of \$200 is waived

Application-Step 1- Gather your Materials and Determine your Eligibility

Two letters of reference must be submitted through PharmCAS. One letter must be from either a science faculty member whom you have taken 2 or more courses with OR from the Pre-Health professions advisor. The second letter may be from a source of your choosing. However, it is recommended that the letter be from a pharmacist of a source who can attest to the applicants potential	The PCAT is not required for admission consideration	There is no GPA requirement for admission. To be competitive cumulative GPA should be 2.7+ and science GPA : 2.7 +. All prerequisite must have an earned grade of C or higher

New PharmCAS Application required every year, application cycle opens early-mid July. All applications must be submitted and all materials received by PharmCAS by Sept 18 for early admission consideration and March 18 for regular admission	The PharmCAS application fee is based on a graduated scale that varies based on the number of programs you choose to receive your application. Refer to the PharmCAS Fee Schedule for cost of application based on number of schools applied to	Applicants must be a US citizen, possess a Green Card, been granted asylum or refugee status, or be eligible for an International Student Visa to be eligible for admission. Tuition is the same for all students regardless of residency
Application-Step 4 and 5- Interview and Decision		
Interview		Deposit and Background Check
An in-person interview with members of the Admissions Committee is required. International applicants may be given the option of an in-person or an online interview. Only selected applicants will be invited to interview. Interview dates are scheduled directly with the applicant by the Admissions Office. When the interview date is confirmed, information will be sent to the applicant regarding local overnight housing options. All accommodation arrangements are the responsibility of the applicant		Class reservation deposit is \$200 due with offer of admission to hold seat. Prior to being allowed to enroll, all accepted applicants will be required to undergo and successfully pass a background check. All offers of acceptance are contingent upon satisfying this requirement
