How do I show official proof of finances (cost of education and living expenses)?

All international applicants requesting an I-20 are required to submit official proof of funding before an I-20 can and will be issued.

The estimate of cost are updated each July for the upcoming academic year, fall/spring. Additional proof is required for the optional summer semester. It is important to note that cost are subject to change without notice.

Documents that **can** be accepted:

- Original document(s) issued directly from a bank (if the bank document is not in English, English translation must be attached.)
- Funding must come from checking or savings accounts.
- Indicate exact balance of account on date of document issuance.
- If funding is not listed in US currency, provide an exchange rate with date and source.
- All proof of funding documents must be dated within 6 months of the first date of classes of the desired term.
- All documents must be certified (all pages signed and stamped by a bank official in a color other than black).
- Submit a copy of assistantship or scholarship letter if receiving funding from UT Chattanooga.

Documents that **will not** be accepted:

- Not accepted: Insurance policies, land holdings, retirement funds, projected income are examples of not accepted proofs.
