In 2008, the University of Chattanooga Foundation consolidated several faculty development and instructional small grant funding to create one "super fund" to fund all faculty development activities at UTC. Traditionally, the funding of these accounts was funded through individual accounts and managed by respective Faculty Senate (Faculty Development and Faculty Research Committees) and a Provost Committee (Instructional Excellence Committee).

By having one account stream and by routing the proposals to the appropriate committee, UTC can better utilize the UC Foundation funds and also reduce duplicative and redundant funding requests. In addition, one account gives all of the groups reviewing proposals flexibility to fund worthy proposals in one area by reducing the funding from another area.

In addition to the account consolidation, the Walker Teaching Resource Center was charged with administrative support to track funds, balance the account and to hold and store all documentation on the funded projects, which provides continuity from year to year for reporting.

Faculty development can be defined in many ways.

The continued professional growth and development of faculty is necessary for institutions of higher education to continue to provide educational programs which: (a) include new developments and knowledge in academic disciplines; (b) reflect new instructional, research, and public service techniques and strategies; and (c) meet changing needs and expectations of students. ... Provision of financial support through grant awards and other means for research or the improvement of instruction, for faculty participation in workshops, short courses and seminars designed to develop new skills in instruction, research and public service, and for faculty participation in major activities of their respective professional associations. (Nashville State Technical Community College, Faculty Development Program Committee, http://www.nscc.edu/inservice/definition.htm).

The Professional and Organizational Development Network in Higher Education defines faculty development as

... those programs which focus on the individual faculty member. The most common focus for programs of this type is the faculty member as a teacher. Faculty development specialists provide consultation on teaching, including class organization, evaluation of students, inclass presentation skills, questioning and all aspects of design and presentation. They also advise faculty on other aspects of teacher/student interaction, such as advising, tutoring, discipline policies and administration.

A second frequent focus of such programs is the faculty member as a scholar and professional. These programs offer assistance in career planning, professional development in scholarly skills such as grant writing, publishing, committee work, administrative work, supervisory skills, and a wide range of other activities expected of faculty.

A third area on which faculty development programs focus is the faculty member as a person. This includes wellness management, interpersonal skills, stress and time management, assertiveness development and a host of other programs that address the individual's well-being.

While not all faculty development programs include all these areas, most of them have as their philosophy the faculty member as the driving force behind the institution; therefore, assisting that person to be as productive as possible will make the entire institution more

productive (http://www.podnetwork.org/faculty_development/definitions.htm, ¶ 2).

At UTC, funding for faculty development has traditionally translated into travel grants (reviewed and funded through the Faculty Senate Faculty Development Committee), mini-research grants and summer fellowship grants (reviewed and funded through the Faculty Senate Faculty Research Committee), departmental speaker series (reviewed and funded through the Faculty Senate Faculty Development Committee), and mini-teaching innovation grants (reviewed and funded through the Provost Instructional Excellence Committee).

This report serves as a yearly report regarding the expenditures of the funds in the following accounts: Ro40130043 UC FDN Fac Dev & Teaching Innovation, UC FDN INST EXC Fund (Grants): Ro41001010 as well as any funds from the past years' accounts.

Plans for the upcoming year

Over the 2009 – 2010 academic year, the Faculty Development and Faculty Research Committees will work to design a single application/proposal form to be used for all grants. In addition, the Provost has approved that the Instructional Excellence grant program to be moved to those two committees to consider instructional innovation/teaching grants. The Instructional Excellence Committee will be renamed as the Walker Teaching Resource Center Advisory Committee, which will plan the Instructional Excellence Retreat each year (funded through the Provost office). The two Faculty Senate Committees will work with the Committee on Committees to discuss the concept of combining the goals of the two committees into one and if that happens will work with the Faculty Handbook Committee to revise and update the Handbook to reflect those changes. With these changes, UTC should begin to offer a more comprehensive funding for faculty development that addresses all faculty roles and responsibilities.
