



## UTC Campus Recreation Youth Swimming Lessons COVID Safety Protocols

- **Screening Questions:** During check-in, each day, parents will be asked COVID screening questions. If the parent answers no to any of the questions, they will not be allowed to participate on that day of class. The questions are:
  - Have you had close contact for 15 minutes or more with someone who has or is suspected of having COVID-19?
  - In the last 48 hours, have you had any of the following symptoms which are new or not explained by a pre-existing condition: cough, shortness of breath, difficulty breathing, fever, chills, repeated shaking chills, fatigue, muscle pain, body aches, headache, sore throat, nasal congestion or runny nose, nausea, diarrhea, vomiting, or loss of taste or smell?
  - Do you currently have a temperature of 100.4 or higher?
- **Class Social Distancing:** Instructors will enforce social distancing of their class by using colored dots that can be placed either on the pool deck or on the bottom of the pool.
- **Mask Requirement:** All people entering the ARC will be required to wear a mask. This includes parents and swim lesson participants. Masks may be removed and placed in the child's swimming basket just before class starts. The masks are required to be put back on at the end of the lesson.
- **Youth Mask Requirement:** Youth under the age of 2 are not required to wear a mask.
- **Class Equipment:** Instructors will make sure that each student has their own swim lesson gear. Gear is not to be shared with other students.
- **Cleaning of Equipment:** Instructors will disinfect all gear used by their students at the end of each lesson.
- **Swim Instructor Mask Requirement:** All Swim Instructors will be required to wear a mask before and after the start of swimming lessons. Instructors will wear a disposable mask while teaching in the water. The mask may be removed by the instructor while demonstrating skills that require them to get their face wet.
- **Guard Requirements:** Three Lifeguards will be on duty during each swimming lesson session. The Lifeguards will be required to wear a facemask throughout their entire shift. Lifeguards will assist in ensuring social distancing during swimming lessons and will help disinfect the pool deck and equipment as needed between classes. Guards are always required to wear a mask while at work.
- **Swim Lesson Coordinator:** The Programming and Events Student Lead, Madison Dayton, will be on the pool deck during each and every swimming lesson throughout the summer. Her job will consist of facilitating Parent Orientations, check in/out, ensuring staff and guests are following all COVID-19 prevention protocols, customer service, and any other tasks needed to ensure the

- safety of our Youth Swimming Lesson program. The Swim Lesson Coordinator is always required to wear a mask while at work.
- **Personal Belonging Storage:** Each student should have their own swimmer basket to store belongings that will not be needed during the lesson (i.e. towel, shoes, shirt).
- **Parent COVID Explanation:** Parents will undergo Parent Orientation on the first day of swimming lessons to explain our COVID-19 prevention protocols to them.
- **Parent/Guardian Deck Requirement:** Parents will sign their child in at the start of swimming lessons and then be required to exit the pool deck. Parents may return to the pool deck 5 minutes prior to the end of their child's swimming lesson. The second to last day of class is Parent's Day. Parents may be present on the pool deck the entire time of the lesson on this day.
- **Parent Waiting Area:** Parents are allowed to walk the track, stand in the lobby area, wait in their car, or wait in the grassy space outside the ARC during the swim lesson session. Social distancing of waiting parents will be enforced by Aquatics Staff and Building Supervisors if needed.
- **Sharing COVID-19 Prevention Protocols:** All swim lesson COVID protocols will be listed on Campus Recreation's website for parents to review prior to registering their child. This information will also be auto sent to the parent/guardian upon registration. Lastly, all COVID-19 prevention information will be shared with parents/guardian during the parent orientation on the first day of swimming lessons for each session.
- **Other:** Upon registration, the parents/guardians will be notified that swim lessons are subject to change due to COVID-19. This could result in cancelations, activity changes, etc. Campus Recreation will remain fluid this summer to match changes and updates Campus Recreation and/or UTC initiates.
