### **PCAT Requirements**

As of July 2017, ETSU's Bill Gatton College of Pharmacy does not require the PCAT.

Statement from ETSU regarding the PCAT: "After analyzing data over the past several years, we have determined that the PCAT is not essential in helping us determine which applicants are best suited for our pharmacy school. Our Admissions Committee continues to take a holistic approach when reviewing each candidate's file, and the candidate's academic record and full PharmCAS application are carefully considered."

#### **Early Decision Application**

ETSU's Bill Gatton College of Pharmacy Participates in the Early Decision application through PharmCAS. The deadline is September 3. In addition to completing the PharmCAS application, you must arrange for PharmCAS to receive all of your official transcripts and fees by the deadline. If your application, transcripts, or fee arrive after the deadline, PharmCAS will automatically change your file from early decision status to regular status. If you are offered admission as an Early Decision applicant, you are expected to accept the offer and will not be permitted to apply to other programs in PharmCAS during the current admission cycle. If, however, you are denied admission as an Early Decision applicant, you may apply to other Pharm.D. programs for an additional fee. Refer to the PharmCAS application fee schedule to determine the cost to apply to each additional program. On October 21 PharmCAS will automatically release all Early Decision applicants who have not been accepted to date, so they may apply to additional programs. Early Decision applicants who are extended an admissions acceptance will receive a \$2,000 scholarship. Additionally, the class reservation deposit of \$200 is waived

<sup>\*</sup> Applicants who not will earn a baccalaureate degree before applying must have met the general education requirements and the math and science prerequisites (listed above) required to be considered for admission

<sup>\*\*</sup>MATH 1130, 1710, 1720, and/or 1730 are prerequisites for MATH 1830 and/or MATH 1950. Additionally these math courses may be required as part of a degree requirement

<sup>\*\*\*</sup> ETSU's Bill Gatton College of Pharmacy requires the completion of MATH 1830 or MATH 1950 for students to be considered for admission, students placing out of math due to ACT must take one of these courses
