

CITI Instructions for New Users – Responsible and Ethical Conduct of Research

There are two ways to log in to CITI. Click the links below for step-by-step instructions.

The next steps are numbered 1-7. These steps will collect information to register your account and place you in the correct course.

Step 1 Choose “University of Tennessee at Chattanooga, The,” agree to the “Terms of Service,” and affirm that you are a UTC affiliate. After selecting your institution, click “Continue to Step 2”.

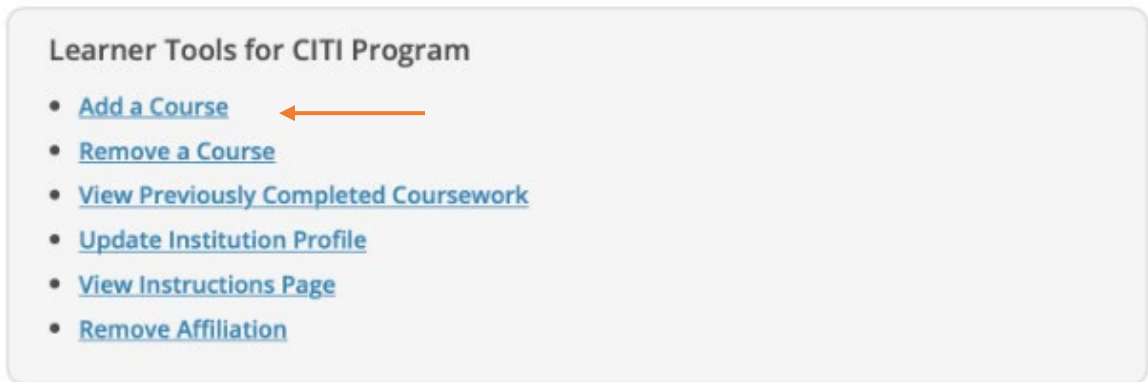

Complete Registration

- After selecting your courses you are given the opportunity to enroll with another institution if needed. If your registration is complete, click on Finalize Registration. You will now be able to access the Main Menu of your account.
- You should see the courses listed in your Course List.
- Begin a course by clicking on the course name. You will be presented with a list of modules, with a short quiz following each module. All required modules within a course will need to be completed in order to earn a completion certificate. Course progress is automatically saved if you log out of CITI, so you may complete a course at your convenience. A quiz score average of 80% must be maintained to earn the Completion Certificate. Quizzes may be retaken as many times as necessary.
