1. IBC 22-01 – Stein – Amendment to add personnel. Approved by Chair 02/28/23

V. New Business

- 1. SOP update
 - a) Recommendation to meet on Monday (04/03/23) to review and vote on SOPs (via ZOOM)
 - b) Reviewed *Roberts Rules of Order* and *Ex Officio* members have full rights to make motions and to vote on committee affairs.
- 2. IBC #23-01 Henry Spratt "BIOL 4220 Principles of Microbiology Laboratory" Revised and resubmitted to address previously identified action items. Includes BSL-1 and BSL-2 activities, but no work with recombinant or synthetic nucleic acids.
 - a) Motion to Approve: Kovach, 2nd Barbosa, all in favor with no objections. abstentions: Spratt, Giles, McClellan and Deardorff.
 - Motion to change start date to 08/10/2023 to allow for the acquisition of new PPE and BSC prior to lab inspection. Inspection set for August 1, 2023 – Deardorff, 2nd McGraw, All in favor, no objections, abstentions: Spratt and Giles.
- 3. IBC #23-02 Henry Spratt "Pathogen monitoring on environmental surfaces in clinics" Revised and resubmitted to address previously identified action items. Includes BSL-1 and BSL-2 activities, but no work with recombinant or synthetic nucleic acids.

- a) Two students worked on this during the current semester. Both have completed research activities. New students will likely be added this summer and will need to be listed as other investigators.

 - b) D.6. needs more detail. Citations would be preferable.
 - c) Unclear of what the project is. Barbosa will speak with her to help explain needed detail.
